

Banlaw FillSafe™ Zero Flow Control Valve – 2” and Venting Level Sensor**Terms and Conditions for 30 Day Free Trial**

1. Offer only valid to ***New Approved*** Customers
2. This offer is not valid to existing customers or distributors of Banlaw Pty Ltd.
3. ***New Customers*** are those which have not held a credit account with Banlaw Pty Ltd within the past 24mths.
4. ***New Customers*** applying for the 30-day free trial of the product must fill out and return the Banlaw Pty Ltd Credit Application Form and Terms (FRM-OPR-14).
5. ***New Approved Customers*** are those customers that have returned the form in clause 4 and Banlaw Pty Ltd have acknowledged receipt and approval of all Commercial Credit conditions and clauses therein.
6. The 30-day Free Trial offer is valid until the 30th of April to all ***New Approved Customers***
7. The 30-day Free Trial offer is granted to the first Twenty-Five (25) ***New Approved Customers*** only or subject to Clause 5, whichever occurs first.
8. Once approved, ***New Approved Customers*** are entitled to only **one (1) set** of the products for the duration of the trial period. One set of products includes the following only;
 - a) 1 off BFCV50 – Banlaw Pty Ltd Flow Control Valve 2 inch.
 - b) 1 off BVLS80 – Banlaw Pty Ltd Vented Level Sensor (80mm).
 - c) 1 off Internal Pilot Line (size determined during trial assessment).
9. All transport and/ or shipping costs, both to the customer and (if applicable) returned from the customer is by the customer. Banlaw Pty Ltd accepts no responsibility for transport and/or shipping costs.
10. Shipping and handling costs are non-refundable.
11. Products will be shipped by availability only. Banlaw Pty Ltd reserves the right to delay the trial period until all purchased products have been dispatched.
12. A Customer purchase order for the list price value of the trial products, being one set, must be issued prior to Banlaw Pty Ltd dispatching of products for the 30-day free trial offer.
13. The 30 days, within the 30-day trial offer, begins upon notification to the customer that the goods have been dispatched from Banlaw Pty Ltd Gateshead, NSW, Australia.
14. Within the 30 days from Dispatch if the customer is dissatisfied with the products performance, the Customer must notify Banlaw Pty Ltd, in writing, of the customer’s dissatisfaction and state why they wish to cease the trial and return the products.
15. All products included within the 30-day trial offer period must be returned within 30 days of the written notification to cease the product trial. failure to return the products within this period may result in Banlaw Pty Ltd raising and issuing a commercial invoice for the list price value of the products in total, for which the customer is entitled to pay as per the Credit Application Form and Terms of conditions agreed upon. If the products are returned in a functioning condition during this 30 day period no further actions may result.
16. All costs incurred for returning the products is the responsibility of the customer.

17. If the Customer is satisfied by the products after or during the 30-day Trial, commencing on Dispatch (refer clause 8), then Banlaw Pty Ltd will raise and issue a commercial invoice for the list price value of the products in total, for which the customer is entitled to pay as per the Credit Application Form and Terms of conditions agreed upon.
18. If after 30 days from Dispatch Banlaw Pty Ltd have received no notification from the customer as to the satisfaction or dissatisfaction of the products during the trial period, then Banlaw Pty Ltd will raise and issue a commercial invoice for the list price value of the products in total, for which the customer is entitled to pay as per the Credit Application Form and Terms of conditions agreed upon.
19. If the customer wishes to return the product within the trial period, all products as listed in clause 8 must be returned in a functional condition. Should the product be deemed "damaged" then Banlaw Pty Ltd reserve the right to charge the customer for the products as listed
20. Banlaw Pty Ltd will assess the condition of the returned products within 7 days of return. Should the products be in a non-functional condition a commercial invoice may be raised.
